Representatives Carol Ehlinger, Megan McFarlane and Nita Conlan from the State Auditor's Office held the Exit Conference reviewing the materials from the 2013-2014 State Audit of the Port of Kingston.

There were two findings reported by the Audit for 2013-2014: Port reported Net Fuel Sales instead of Gross Fuel Sales, which had no impact on bottom line, but was indicated as an internal allocation issue. Auditor's recommend a change in reporting to reflect Gross Sales.

Due to the Auditor's investigation into the Port's report of loss of Public Funds, there was focused discussion and review of the Port's cash handling policies and internal controls and included a transparent discussion on the controls in place during the period that the loss occurred. Commissioners discussed access to guidelines for improved controls and continuing education for Port of Kingston Staff through the State Auditor's Office and other Statewide and Federal programs. State Auditor's Office Representatives responded with a verbal list of recommendations for online and in-person guidelines, checklists courses and programs available to Port Staff and Management.

COMMISIONER'S RECOMMENDATION:

Review training, internal controls and appropriate tools to continue to pursue excellence in internal controls and accountability.
