



Permanent Moorage Waitlist Application

Upon payment of a NON-REFUNDABLE annual fee, each applicant may submit one waitlist application and indicate, no more than, one (1) size of berth they are willing to accept. Current tenants wishing to transfer within permanent moorage are subject to the NON-REFUNDABLE annual fee. Current tenants wishing to acquire a second slip must pay the NON-REFUNDABLE annual fee and submit a new application.

The Port allows an overhang on each dock at the discretion of the Port Manager. Fees are based on the overall length of the vessel or berth; whichever is greater. The overall length includes the bowsprit and dinghy.

It is the sole responsibility of the applicant to keep the Port of Kingston advised of their current telephone number or email address. If you cannot be contacted by the Port Office, via phone or email, when a slip becomes available, you will be removed from that waitlist. If the Port Office does not receive confirmation of slip acceptance within 72 hours of attempted contact, we will move to the next applicant on the list.

Effective January 2015, there will be an annual fee to remain on each waitlist. An annual fee of \$25.00 will be invoiced each December. If your payment is not received by January 31st, you will be removed from the waitlist.
